# New in this release

The following features are new for the BBM Enterprise snap-in for BlackBerry UEM. To use these features, BlackBerry UEM version 12.12.1 is required.

Export selected Active Directory attributes to the Cloud Directory	You can now specify the user attributes that are exported to the Cloud Directory from Active Directory using a BBM Enterprise profile. For example, you can specify that a user's department or first and last name are not exported.
Use Active Directory user display name in cloud directory	You can now specify whether to use the user display name in Active Directory as the user identifier in the BBM Enterprise cloud directory using a BBM Enterprise profile.

## Fixed issues

A BlackBerry *myAccount* user that was imported to a UEM tenant via BlackBerry Workspaces synchronization (instead of being imported into UEM by an administrator) could be activated for BBM Enterprise in only one organization and tenant. (JI 2631454)

# Known issues

Some BBM Enterprise licences are not released after the BBM Enterprise service is removed from a user group. (JI 2801977)

Expired BBM Enterprise passwords are not shown in the BBM Enterprise section of the User screen. (JI 2603298)

If the user sets the MDM activation password, then the BBM Enterprise activation password, and then tries to activate on MDM, the MDM activation fails. Also, if the user sets the BBM Enterprise activation password, then the MDM activation password, and then tries to activate on BBM Enterprise, the BBM Enterprise activation fails. (JI 2533454, JI 2324363)

**Workaround:** Set the activation password for one service and activate it before setting the activation password for the other service.
