The BlackBerry Administration Service attribution notice file (Notice.Doc) is now in compliance with Open Source Software licensing. (JI 598952.)

Database Updates

The following enhancements are made to the BlackBerry Enterprise Server for Microsoft Office 365 State database stored procedures:

- reduced length of time the purge job needs to prepare data to delete
- improved job performance while deleting message item records
- reduced deadlocks while deleting message item records

The install scripts update the TimeZoneRegistryMap table in the BlackBerry Enterprise Server database for the "Libya Standard Time" time zone. (JI 598190).

Microsoft Exchange Adapter

The "x-AnchorMailbox" header is now included in all autodiscover calls for Microsoft Exchange Web Services (JI 757327).
