BlackBerry Access for Android version 3.3.0.138

This release of BlackBerry Access for Android features the following enhancements:

- **Android 12:** BlackBerry Access is compatible with Android 12.
- **Bookmarks:** Users can now import and export bookmarks, which allows them to share their bookmarks on multiple devices.
- **Autofill of credentials:** The new “Allow to save web form credentials and credentials autofill” option in the BlackBerry Access app configuration allows users to automatically fill in fields with saved passwords and credentials. BlackBerry Access for Android supports password autofill for form-based authentication. Saved passwords will be populated automatically unless there is more than one set of credentials associated with a site. When this happens, the user is prompted to select the autofill credentials. Android users can tap Settings > Clear credentials to remove saved credentials.
- **Clear credentials on log out:** Web developers can use the new JavaScript API to clear credential storage when a user logs out of their account on a web page. If you are using the API, when you select the “Allow JavaScript to clear credentials” option in the BlackBerry Access app configuration, you then specify which domains or hosts the policy should apply to. You can add up to 10 domains. When you enable this feature, users will be prompted for credentials during subsequent logins.
