BlackBerry Access for iOS fixed issues

The QR code did not generate when users tried to log in using Singpass. (FIRST-18076, GMAGDIOS-16725)

On devices that are running iOS 17, when users restarted BlackBerry Access without closing open webpages, the **New Tab** tab stopped responding. (FIRST-18063, GMAGDIOS-16455)

Users were prompted to enter their Kerberos credentials when they attempted to log in to login.microsoft.com using SSO. (FIRST-18040, GMAGDIOS-16593)

BlackBerry Access for Android fixed issues

The color codes on the BlackBerry Access screens have been updated to the custom accent color. (GMAGDAND-12372)

When users tried to delete a bookmark folder from BlackBerry Access, BlackBerry Access stopped responding. (GMAGDAND-12322)

When "Enable Web Proxy" and "Use Proxy Auto Configuration" was enabled on BlackBerry UEM, and the URL for the PAC file location began with a square bracket ([), BlackBerry Access stopped responding. (GMAGDAND-12308)

In the BlackBerry Access Downloads screen, when users tapped a filter option (for example, Video, Audio, or Images) the filter didn't work. (GMAGDAND-11642)
