What's new in BlackBerry Access 1.8.0.33

- Platform upgrade to Chromium 61
- Users can reuse their authentication credentials that they use to access webpages.
- Users can open Skype meetings in the browser.
- Allow webpages from domains that aren't listed in the allowed domains in Connectivity profiles to open in the native browser.

What's new in BlackBerry Work 1.8.0.8207

- When configuring S/MIME, the Sign and Encrypt message options are only shown if the user's public and private key pair is present in the BlackBerry Dynamics Certificate Store. If these options are not available, a valid Public and Private key pair is not available in the BlackBerry Dynamics Certificate Store.
- Users can create private groups of contacts.
- Integrated rich-text editor that allows users to edit and format text in the mail app.
- Administrators can disable Kerberos constrained delegation.
- Administrators can specify the EWS server that the mail app uses.
- ADAL-based authentication is supported.
- Streaming notifications.

Fixed issues in BlackBerry Access 1.8.0.33

- After a user clears all downloaded files from the downloads page, the cleared files still display when the user opens a browser prompt to choose files to upload. (GMAGDMAC-2915)
- A problem occurs with PAC file download and verification on BlackBerry Access installed on macOS 10.13 compared with 10.10. (FIRST-15035)

Known issues in BlackBerry Access 1.8.0.33

• Credentials saved from Mail App are prompted to be saved when loading a non-authenticated webpage from bookmarks after upgrade. (GMAGDMAC-3412)

Fixed issues in BlackBerry Work 1.8.0.8207

- After a user accepts, declines, or tentatively accepts a meeting invite, the meeting invite email is not removed from the user's inbox folder to the deleted items folder. (WEBAPPS-5258)
- When a user searches for a contact, the first search result is not selected automatically. (WEBAPPS-5257)
- If a user clicks a user name in an email header and views the user's profile, the profile information displays, but that user is not displayed in the contacts list. (WEBAPPS-5207)
- If a user receives an email message that uses a certificate that is not trusted, a "Certificate has expired" error message displays instead of an error message that indicates that the certificate is not trusted. (WEBAPPS-3608)
- BlackBerry Access version 1.7.1.54 shows incorrect BlackBerry Work calendar behavior if the default language set to Japanese. (FIRST-14921)

Known issues in BlackBerry Work 1.8.0.8207

- If users upgrade from an earlier version of BlackBerry Work, when they first open the mail app from theBlackBerry Dynamics Launcher, they must enter their credentials again but they do not lose any existing email messages, calendar events, or contacts.
- After creating a new folder, the option does not dismiss automatically (WEBAPPS-5685)
- A duplicate contacts group is created each time a group distribution list is saved after viewing it in an email message. (WEBAPPS-5794)
- Duplicate scroll bars are shown in the Out of Office and Signature forms. (WEBAPPS-5891)
- Pressing the End key does not move the cursor to the end of the edited line. (WEBAPPS-5889)
- A blank screen is shown to a user after mail account setup is completed for an ADAL or KCD configuration. (WEBAPPS-5919) **Workaround:** The user must refresh the screen using cmd+r.
