BlackBerry Access version 1.9.0.57 and BlackBerry Work version 1.9.0.8214

To install this version of BlackBerry Access and BlackBerry Work for Windows, you can either do a fresh install or upgrade from a previous version.

What's new in BlackBerry Access and BlackBerry Work

- TLS and SSL client certificate authentication is now supported in BlackBerry Access for Windows.
- Spell check is now available in BlackBerry Access and BlackBerry Work for Windows.
- Users can edit Microsoft PowerPoint and Microsoft Word documents directly in BlackBerry Access for Windows without requiring an outside editor.
- Email and calendar notifications are now supported in BlackBerry Access and BlackBerry Work for Windows. You can control notifications with the new **Disable Notifications** app setting that specifies whether BlackBerry Work displays notifications for mail and calendar events.
- A new **Allow user to set home page (Mac and Windows only)** app setting specifies whether users can set their own home pages in BlackBerry Access for Windows.

Policy, schema, or API changes

- A new **Allow user to set home page (Mac and Windows only)** policy was added.
- A new **Disable Notifications** policy was added.
- Support for BlackBerry Access for Windows was added to the **Do not prompt client cert authorization for all sites** policy.
- Support for BlackBerry Access for Windows was added to the **Do not prompt client cert authorization for white listed sites only** policy.

Fixed issues in BlackBerry Access

- Email messages that are received with plain text are changing formatting when replying using BlackBerry Access for Windows version 1.8. (FIRST-15394)

Known issues in BlackBerry Access

- Windows 10 and Windows 8.1 are blocking the ability to upgrade BlackBerry Access due to a lower Windows OS version check. The user is prompted to update the software on the device but only a Close button is displayed. (GMAGDWIN-4649) **Workaround:** Run the BlackBerry Access executable as Administrator.
- The shortcut to select all content (Ctrl+A) is not working for .pptx and .docx documents (GMAGDWIN-4496)
- Tables cannot be removed from edited documents. (GMAGDWIN-4493)
- A few items are missing on the Edit tab in .pptx documents. (GMAGDWIN-4466)
- A new page is not created when a user enters text and presses Enter at the end of a page (GMAGDWIN-4457)
- Mail signatures are not appearing when a user selects the "Share link with e-mail" option from the browser. (WEBAPPS-6021)
- The first email message is not automatically selected and content is not shown after activating BlackBerry Access and completing the initial synchronization successfully (WEBAPPS-5787)
