# What's new in BlackBerry AppSecure SDK version 0.7 beta

Feature	Description
Rebranding of the SDK	The SDK was previously known as the BlackBerry Spark SDK. It has now been rebranded to the BlackBerry AppSecure SDK.
Changes to software requirements	<ul style="list-style-type: none"><li>• The minimum required iOS version is now iOS 14.</li><li>• The minimum required Android OS version is now Android 8.</li><li>• The minimum required Android SDK API level is now 26.</li></ul>
Network security check	On iOS and Android devices, if the SDK is unable to connect to the BlackBerry Protect cloud services, it determines that the current network is not safe.
Insecure Wi-Fi check	On Android devices, the SDK periodically checks the properties of the current Wi-Fi access point to determine if it is secure.
Improvements to error handling	This release includes improvements to error handling when the SDK APIs are used before the library is properly initialized.
