BlackBerry Connect for Android 3.4.0.11

This release of BlackBerry Connect for Android features the following enhancements:

- Specify default 'Away' setting: Administrators can set the default period of inactivity (in minutes) before the user's presence status changes to 'Away'. If you enter a 0 (zero), users' presence status never changes to 'Away'. By default, this feature is enabled and users' status changes to 'Away' after 30 minutes of inactivity.

Optionally, you can restrict users from selecting an 'Away' value in BlackBerry Connect app Settings. By default, users can select a time.

Fixed issues

There are no fixed issues in this release.

Known issues

Some users that are enabled for persistent chat and are members of more than 100 rooms don't receive invitations on the desktop client or the BlackBerry Connect app when they are added to additional rooms as members. (GCC-7019, GEMSS-5886)

Android users cannot log in to Skype for Business Online when using ADFS servers for authentication. For more information, visit support.blackberry.com/community to read article 57409. (GCC-6377)

Workaround: Sign the TLS certificate used for ADFS with an external CA.

When persistent chat is enabled and users update to the latest build, the persistent chat feature options are not available. (GCC-5532)

Workaround: Log out and log in to BlackBerry Connect if BEMS is upgraded before the BlackBerry Connect app is upgraded.

In a Skype for Business environment, when users change their status in BlackBerry Connect, the status doesn't update on the desktop client. For more information, visit support.blackberry.com/community to read article 42659. (GCC-4980)

Users do not receive some group discussion invitation notifications when the BlackBerry Connect app is in the background, and users forced BlackBerry Connect to quit or signed out of BlackBerry Connect, and then started. (GEMSS-6225)

Workaround: Search for the room name and join.
