Changes to OS support	September 2024 iOS: 3.17.0.253	BlackBerry Connect is now compatible with iOS 18.
Usability enhancements	September 2024 iOS: 3.17.0.253	When users authenticate the app, the number of times that the app switches between the authentication delegate app is reduced. Also, one password will be reused for all of the BlackBerry Dynamics apps (for example, BlackBerry Access, BlackBerry Work, BlackBerry Connect, BlackBerry Notes, and BlackBerry Tasks) that are running 3.17 or later. This feature will allow users to update the password from one app and apply it to all of the BlackBerry Dynamics apps.
Policy enhancements	September 2024 iOS: 3.17.0.253	BlackBerry Connect no longer supports the app level policy "Prevent Screenshots on iOS" devices. You can now prevent users from taking screenshots from BlackBerry Dynamics apps (for example, BlackBerry Connect, BlackBerry Work, BlackBerry Tasks, and BlackBerry Notes) using the new "Do not allow screenshots on iOS devices" BlackBerry Dynamics profile setting in the BlackBerry UEM.
