After you opened a Microsoft Excel file on iPhone or iPad devices, moved the file to the background and then moved it to the foreground, the file didn't display correctly. (FIRST-17822)

BlackBerry Edit might have stopped responding when a user opened a Microsoft Excel file that contained Japanese characters. (FIRST-17806)

BlackBerry Edit might have stopped responding when a user opened a Microsoft Excel file that contained Japanese characters. (FIRST-17806)
