## ios

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (BBEDIT-238)

You can't select multiple files in BlackBerry Edit and send them as attachments. (BBEDIT-56)

## Android

The incorrect slide number displays at the bottom of the slides menu after the last slide is deleted from a .pptx file. (BBEDIT-427)

When you open a Microsoft Word document, the subsection numbers might not display correctly. (BBEDIT-424)

When you open a Microsoft Excel spreadsheet that was attached to an email, you cannot use a drop-down list filter to edit the spreadsheet. (BBEDIT-238)

You can't select multiple files and send them as attachments in BlackBerry Work. (BBEDIT-56)
