## **Summary**

Microsoft published guidance for the “PrivExchange” Elevation of Privilege Vulnerability on February 5, 2019 in Security Advisory [ADV190007](#).

## **Impact**

After implementing the guidance in the Microsoft Security Advisory, BEMS subscriptions and notifications no longer work. The following message displays in the BEMS console: “You have exceeded the available subscriptions for your account. Remove unnecessary subscriptions and try your request again.”

## **Recommendation**

Review the Mitigations section in the Microsoft security advisory.
