Multi-Tenant Console 2.11 release notes

This release of BlackBerry Multi-Tenant Console features the following enhancements and fixed issues.

Enhancements

JWT stored HTTPS only

JSON web tokens (JWT) are now stored in HTTPS only, samesite cookie.

GovCloud SSO

GovCloud is now available for the Multi-Tenant Console. This includes an SSO login. See the MTC guide for more information.

Fixed Issues

- Fixed an issue where users were able to enter a negative number when filtering on the number of users. (MSSP-1641)
- Fixed an issue where a tenant did not get the Application option in the console. (MSSP-3653, MSSP-3717)
- The support login can be re-enabled if it was removed from an account. (MSSP-3777)
- Fixed an issue with the virus and malware report creation failing. (MSSP-3785)

New features

Policy details report

The policy details report allows administrators to see all of the settings for a policy, including the name, each setting, each value selected for a setting, and a short description of each setting.

- The policy details report is a .csv file, so the data can be sorted.
- Use the tenant name report filter to limit the amount of content in the report.

Enhancements

SSO login added to the audit log

The audit log displays the user and the date/time the user logged on using SSO.

Bug fixes

- Fixed an issue with the tenant shutdown list page with the names being cut off, incorrect font size, and other formatting issues. (MSSP-3598)
- Added SSO logins to the audit log. The audit log displays the user and the date/time the user logged on using SSO. (MSSP-3711)
- Fixed an issue with policy templates not saving the CylanceOPTICS and data privacy settings. (MSSP-3741)
