- In the BlackBerry Dynamics profile: The **Do not allow copying data from BlackBerry Dynamics apps into non BlackBerry Dynamics apps** checkbox is cleared.
- In the BlackBerry Notes app configuration, the **Allow receiving and opening attachments** is selected.

BlackBerry Work for iOS app users weren't consistently prompted for Face ID or their password when they unlocked the BlackBerry Notes app after a period of inactivity. (G3IOS-37140)
