- **Attachment improvements:** The following improvements were made to attachments:
 - Users can add images taken with the device camera to a task. If an image is larger than an organizations policy allows, a user can resize the image.
 - Users can add images stored in the photo library to a task. If an image is larger than an organization's policy allows, a user can resize the image.
