## BlackBerry Tasks for iOS fixed issues

Users were unable to use MSAL to authenticate with BlackBerry Tasks and received the following error message: **No valid client certificate found in the request.** (FIRST-18093, G3TASKS-11156)

When users created a task and added a bullet or number to the Notes field, the Notes field displayed the placeholder text. (G3TASKS-11152)

When users tapped the keyboard Undo button on their organization's password screen, BlackBerry Notes stopped responding. (G3TASKS-11131)

## BlackBerry Tasks for Android fixed issues

On devices activated on Microsoft 365, after users changed the time zone from Australia to India, the date for the task was different on the device compared to the date for the tasks in Microsoft 365. (G3TASKS-11155)

When the font size was set to the largest setting, the download progress bar was not displayed. (G3TASKS-11146)

When the time zone was set to Ciudad Juarez and users attempted to create a new task, BlackBerry Tasks stopped responding and displayed the following error message: **Update failed: Unknown error**. (G3TASKS-11141)

The month localization for tasks was displayed in English and not as the set language in the device settings. (G3TASKS-11135)

## BlackBerry Tasks for Android known issues

In environments with the following configuration, users cannot select and copy text from downloaded attachments:

- In the BlackBerry Dynamics profile: The **Do not allow copying data from BlackBerry Dynamics apps into non BlackBerry Dynamics apps** checkbox is cleared.
- In the BlackBerry Tasks app configuration, the **Allow receiving and opening attachments** is selected.
