Summary

After you upgrade to BlackBerry UEM 12.13, any changes that you made to the Default BlackBerry Dynamics profile prior to the upgrade are reset to the original default values.

Note: This issue does not affect BlackBerry UEM Cloud.

Impact

This issue occurs on BlackBerry UEM instances that were previously upgraded from BlackBerry UEM 12.8 directly to BlackBerry UEM 12.10, before upgrading to later versions.

When this issue occurs in your environment, you might notice the following:

- **Environments that use BlackBerry Dynamics:** Administrators will notice that changes made to the Default BlackBerry Dynamics profile are no longer present. As a result, configurations made in the profile such as authentication delegates and password requirements, will not be enforced for any users that have the Default BlackBerry Dynamics profile assigned to them.
- **Environments that do not use BlackBerry Dynamics:** Users will notice that the BlackBerry UEM Client has been provisioned and enrolled in BlackBerry Dynamics. The BlackBerry UEM Client will prompt users to create a BlackBerry Dynamics container password.
