#### Summary

When you upgrade the BlackBerry Connectivity Node to version 12.17.1, the following error message might be displayed: "Unsuccessful See the log file for details".

#### **Impact**

- BlackBerry Connectivity Node for UEM versions 12.16.1 and 12.17.0 are affected by this upgrade issue.
- · The BlackBerry Connectivity Node for BlackBerry UEM Cloud is not impacted.
- Other setup types for BlackBerry UEM such as Primary BlackBerry UEM components and management console installations are not affected.
