Summary

If a user's Android device is using a recent version of the Android 11 or 12 OS, .local DNS resolution does not happen. To find the version of Android OS that their device is using, users can navigate to Settings > About Phone > Software Information > Google Play system update.

Impact

The recent Google Play system updates for Android 11 OS and Android 12 OS do not support .local as an internal domain extension.
