Apple VPP account	An Apple VPP account defined in the system.
Apple VPP accounts	A collection of Apple VPP accounts.

lastPasswordChangeTime	Date and time of the last password change.

Properties	Description
lastPasswordChangeTime	Date and time of the last password change.

Path	Description
GET <code>/{tenantGuid}/api/v1/apnscert</code>	Get the APNs certificate status.

### Resource: Apple VPP Account

Properties	Description
GET <code>/{tenantGuid}/api/v1/vppAccounts</code>	Get details of Apple VPP accounts from a query.
GET <code>/{tenantGuid}/api/v1/vppAccounts/{vppAccountGuid}</code>	Get details of an Apple VPP account by GUID.
