# BlackBerry Work for iOS version 3.10.0.9313

This release of BlackBerry Work for iOS features the following enhancements:

## Event classifications:

- Administrators can specify whether to allow users to set event classifications in the BlackBerry Work app configuration settings.
- Users can add classifications and caveats to events that they create. The classifications and caveats display in the subject field of the event.
- Users can view classifications in the details of an event that they've been invited to. Note that active classifications are displayed in blue, and users can't edit any of the classifications.
- Event organizers can edit the classifications of an event after that they created it.
- When you convert an email message to an event, any email classifications are also included in the event invite. Note that the classifications are editable.
- When you respond to a calendar invitation by tapping Email Attendees or Forward Event, any classifications are also included in the email message.

## Calendar updates:

- Users can now view external calendar events in the Agenda view.

## Sending feedback improvement:

- It is now easier for users to upload log files and attach diagnostic reports to email messages.

## Email improvement:

- When there is no valid certificate for an email message, users cannot open the message and a warning is displayed that the message is not accessible.

When editing a contact, the notes field might have displayed HTML code. (FIRST-17866, FIRST-13922)

MSAL authentication failed if an SSO URL was set in the Office 365 Sign On URL field of the app configuration. (FIRST-17858)

When an .ics file was opened, BlackBerry Work saved the meeting to the calendar using GMT instead of the time that the meeting was set for. (FIRST-17857)

The Auto Advance > New Mail feature was not advancing users to the newest email message after they deleted an email message. (FIRST-17843)

RSA SecureID compressed token format (CTF) URL links were not working. (FIRST-17830)

If a user had selected Calibri in the 'Compose Font Selection' field, after upgrading the BlackBerry Work app, the font was changed to Times New Roman. (G3IOS-31901)
