## Fixed issues

When the signing certificate in a signed email was tapped in BlackBerry Work, an error message displayed. (FIRST-17940)

When an .ics file was opened in BlackBerry Work, an error message was displayed. (FIRST-17947)

When a .zip file attachment containing a file titled in Japanese was opened, if Japanese was not installed on the device, the title appeared abnormally. (FIRST-17944)

Recurring meetings created in Egypt before the reintroduction of DST displayed an hour behind in BlackBerry Work. (FIRST-17990)

If the last four digits of a mobile phone number was searched in BlackBerry Work Contacts, the contact was not listed in the search results. (G3IOS-33821)

The size of an email attachment may have been displayed incorrectly in the email detail view. (G3IOS-33958)

If a device had Stage Manager enabled and was connected to an external keyboard, the rich-text editor toolbar was not displayed when replying to an email in BlackBerry Work. (G3IOS-33641)

Users were not able to add additional attachments to an existing Microsoft Teams event that already has an attachment. (G3IOS-33973)

When editing an event in BlackBerry Work, the "Create Teams meeting" option is not displayed. (G3IOS-34614)
