## **BlackBerry Work for iOS**

#### BlackBerry Work for iOS version 3.9.0.9094

#### Calendar updates:

- The propose new time feature is now enabled by default. In the app configuration, the feature option has been moved from the Beta tab to the Calendar tab.
- You can set which day to display as the first day of the week in your calendar. Note that you can no longer use the "Device system settings" option to use the Calendar settings you have specified in your iOS settings.
- You can choose which days display as the workdays for the week in the calendar week view. Note that you can
  no longer use the "Device system settings" option to use the Calendar settings you have specified in your iOS
  settings.
- When a meeting invitee sends a new time proposal request, the original time of the meeting is displayed in the request.

#### Meeting updates:

- When a meeting invitee sends a new time proposal request, they can add a comment to the request.
- When a meeting invitee sends a new time proposal request, the original time of the meeting is displayed in the request.
- Users can now use formatting such as bold and colors in meeting notes.

Signature update: Users can now use formatting such as bold and colors in their signatures.

**UI update**: When users start to create a new contact or meeting invitation or start to create a feedback item, if they swipe down on the screen, a message asks them if they would like to keep editing the item or discard the changes.

Home screen widget: iOS 14 users can use widgets on the home screens of their devices.

BlackBerry Work stopped responding when a user viewed a contact. (FIRST-17809)

Users could not report a signed email message as a phishing email. (FIRST-17790)

The Join button for a Skype for Business meeting did not work if the link used a custom prefix. (FIRST-17788)

Tapping on a link to a Zoom meeting in the Calendar did not work. (FIRST-17786)

If a device was using iOS 14 or iOS 15, BlackBerry Work stopped responding after a user opened it. (FIRST-17759)
