Summary

The internal.watchdox.net certificate expires on February 26, 2021, for all BlackBerry Workspaces Appliance-X 8.0 and later environments.

Impact

BlackBerry Workspaces Appliance-X environments use the internal.watchdox.net certificate to validate internal traffic. When the certificate expires, all Workspaces Appliance-X on-premises customers will experience a loss of services, such as the inability to download files or view files online.

Resolution

To prevent loss of service, use the instructions in [KB article 72980](#) to upgrade your certificate before February 26, 2021.

Future releases of the software will include an updated certificate.
