# New in this release

## BlackBerry Workspaces for Android version 11.5.2

**Content sharing restrictions:** Support for the Workspaces administrator capability to restrict content sharing to specific domains.

## BlackBerry Workspaces for Android version 11.5.1

## BlackBerry Workspaces for Android version 11.5

**Sharing with email domain:** Administrators can now control the option of allowing users to share Workspaces content with an entire email domain.

## BlackBerry Workspaces for Android version 11.0

**See full file names:** You can now see full file names when browsing Workspaces.

**Support for video streaming:** You can now stream videos from local Workspaces folders. This feature is supported for .mp4, .webm, .mov, .ogg (audio), and .mkv formats. Note that this feature is not available for transient workspaces.

**Removed the option to create Office documents:** The option to create a new Microsoft Office document in Workspaces has been removed.

# Fixed issues

## Fixed issues in version 11.5.2

When sharing a file from the BlackBerry Work to the Workspaces app, the Workspaces app stopped responding after you selected the target folder. (WSCLIENT-1224)

## Fixed issues in version 11.5.1

Changes to regionalization for BlackBerry Dynamics to enhance secure communications with the BlackBerry Infrastructure. (GD-60435)

On devices running Android 13, you couldn't select the BlackBerry Work app to use it to activate the BlackBerry Dynamics version of the Workspaces app. (WSCLIENT-1096)

## Fixed issues in version 11.1

You could not open a file while in airplane mode even if it was downloaded for offline access. (WSCLIENT-908)

<p>* When watermark text is set to the large size, the watermark text cuts off the page. (WSCLIENT-1148)</p>
<p>After upgrading the BlackBerry Dynamics version of the BlackBerry Workspaces app, you are prompted to sign in again. (WSCLIENT-1137)</p>
<p>When there is one file in a Workspaces folder and it is marked for offline access, the entire folder is marked for offline access. (WSCLIENT-911)</p>
<p>When you want to add permissions for a user on a file, the user's email address is removed after you select the option to inherit permissions. (WSCLIENT-849)</p>
<p>When an administrator restricts the ability for you to change the permissions when sharing files, you can't share files that cannot be DRM-protected (for example, .zip files). (EPIC-1045)</p>
<p>After you disable the "Sync files only over Wi-Fi" setting, the setting is enabled when you sign out and sign in again. (WSCLIENT-418)</p>
<p>When trying to edit a Microsoft PowerPoint (.pptx) file, the keyboard does not appear. (AND-6626)</p> <p><b>Workaround:</b> To display the keyboard, long-press and select Edit Text.</p>
<p>When a user tries to save a Microsoft Office document and taps Create new folder, a "Failed to create folder" error displays. (AND-5997)</p> <p><b>Workaround:</b> Save the document to an existing folder, then create a new folder and move the document into the new folder.</p>
<p>When a user tries to upload a large file, a "Connection error" message might display. (AND-5930)</p> <p><b>Workaround:</b> Try to upload the file again or use the BlackBerry Workspaces web application to upload the file.</p>
