# New in this release

## BlackBerry Workspaces for macOS version 11.7.1

**Content sharing restrictions:** Support for the Workspaces administrator capability to restrict content sharing to specific domains.

## BlackBerry Workspaces for macOS version 10.1.1

**Sharing with email domain:** Administrators can now control the option of allowing users to share Workspaces content with an entire email domain.

## BlackBerry Workspaces for macOS version 10.1

**Support for macOS 11:** BlackBerry Workspaces for macOS now supports devices running macOS 11.

## BlackBerry Workspaces for macOS version 10.0

**App renamed to BlackBerry Workspaces:** On macOS computers, the app is now uniquely named “BlackBerry Workspaces”.

**Default file permissions:** Administrators can set the default file sharing permissions and restrict the ability of users to change them when sharing files.

When you downloaded a file from Workspaces, the last modified date and time is from the download, instead of the last modified date and time of the file that was in Workspaces. (WSCLIENT-1216)

# Known issues

On devices running macOS 12 or 13 that have its system language set to French, German, or Japanese, an error message (13206) appears when you try to share a workspace and assign the "Contributor" or "Visitor" role. (WSCLIENT-1098)

When using the Workspaces Viewer, the dialog that appears for "Send a copy" or "Share annotations" options does not display the title properly. (WSCLIENT-1010)

If you uninstall and reinstall the Workspaces app, the Workspaces context menu displays duplicate items. (WSCLIENT-795)

When you open the context menu for a Workspaces file, the "Lock File" option appears even if an administrator restricted that ability. (WSCLIENT-793)

When an administrator restricts the ability for you to change the permissions when sharing files, you could not share files that cannot be DRM-protected (for example, .zip files). (EPIC-1045)

When you are using the line drawing tool, the annotations toolbar might display out of frame. (MAC-3870)

If you have the sharing window open when you switch to dark mode, the Add members field displays in white. (MAC-3824)
